What is TEMPUS?



- Tempus is the European Union's programme, which supports the modernization of higher education in the Partner Countries of Eastern Europe, Central Asia, the Western Balkans and the Mediterranean region, mainly through university cooperation projects.
 - To support the modernisation of Higher Education in Partner Countries of the surrounding area, including Central Asia.
 - To establish an area of cooperation between the European Union (EU) and the Partner Countries.
 - To favour voluntary convergence with the EU developments in the field of Higher Education.



TEMPUS Approach



- Institutional cooperation.
- Bottom-up programme mainly implemented through calls for proposals seeking projects targeting reforms in higher education institutions and/or systems.
- Strong involvement of national authorities.
- Strong accent on dissemination, sustainability and exploitation of results.
- Complements other EU mobility programmes (e.g.Erasmus Mundus).



TEMPUS: Types of Actions



- Joint Projects: implemented at institutional level to reform curricula, improve university governance, create more links with society.
- Structural Measures: implemented at national level for the development and reform of national higher education structures and systems in Partner Countries.
- Accompanying Measures: dissemination and information activities (conferences, studies, exchange of good practice, National Tempus Offices, Higher Education Reform Experts, etc.)



TEMPUS Grant size



- 500 000 1.500 000 Euro, both for Joint Projects and Structural Measures project
- Minimum 10% co-financing
- 7% overhead support
- Project duration 24-36 months

Our TEMPUS Project



The objective of this are summarized into three main categories:

- 1) National standards for Software Engineering master education that includes new courses on IT innovation and entrepreneurship.
- 2) Development of the Virtual Innovative Space that creates a sense of community among Ukrainian students, researchers and IT professionals and promotes their creativity and innovation.
- 3) Establishing a set of guidelines and recommendations for adoption on a national scale for university company cooperation with a focus on student innovation and entrepreneurship.



Goals to be achieved



Specific goals in connection with the project objectives are:

- Identification of the best models and frameworks for university company cooperation.
- Development of an infrastructure that enables the sustainability of a new ecosystem of university-company cooperation in Ukrainian context.
- Implementation of Virtual Innovative Space using social technologies to maintain contacts between students, companies and universities as well as to enable knowledge transfer between the actors.
- To influence the national standard for IT education in Ukraine.
- To develop and deliver new course on IT innovation and entrepreneurship for Ukrainian staff and students.


